Old Windsor Parish

When we put out our Newsletter in February 2020 little did we know what the next two years would bring. The Covid pandemic changed our lives.

All the plans that we made ,individually and as a community , were put on hold while we adjusted our priorities.

Cllr Lynne Jones, Jane Dawson (Chair of the Parish Council) and Debra Dulake (OWPC social worker for Older People) set up and ran the **Covid support network** in Old Windsor Parish. With an army of volunteers from the Old Windsor Community this supported over 100 vulnerable residents. Thank you to all who volunteered to be paired up with a vulnerable person/family, donated and delivered we couldn't have done it without you.

We are told that the promised 'A308 review', started in early 2019, is now in draft form. Our concerns regarding the ever increasing traffic along the Straight Road, and how we can mitigate against it, were put on hold until this full review has taken place. We wait, with interest, as to the findings of the draft study.

As the A308 bisects our village residents have told us their concerns around certain junctions, traffic management along Burfield Road/St Lukes and the pollution levels.

Local flooding issues are always in our minds and we have kept an eye on river levels. Unfortunately RBWM, due to financial challenges, did not honour its commitment to

partnership funding of the **River Thames Scheme** and it has progressed without section 1 (Datchet to Egham). In August 2010 the Environment Agency Flood Risk Management Strategy Report stated that there was no viable alternative and we are convinced that there are no short term measures that will protect the village in the way the Jubilee River protects Maidenhead and Windsor. RBWM was not willing to borrow the £40m to protect home in Old Windsor, Wraysbury and Datchet but were willing to borrow that amount to build a new Leisure Centre in Maidenhead. Drainage works have taken place at the Burfield Road/ Priest Hill junction and a soakaway installed at Meadow Way to alleviate the issues we

have seen regarding standing water. Parish Councillor Malcolm Beer is in talks regarding the area outside the Post Office on Straight Road.



Old Windsor Library was recommended for closure in last years savings proposals but due to intense lobbying and the Parish Council agreeing to subsidise the library costs it has remained available to the residents. It is a case of 'use it or lose it'. Opening times are Wednesdays 2.30pm to 5.30pm and Saturday 10am to1pm

The Tapestries came under threat from the freeholder wishing to sell the site. The first we knew about it was when residents expressed their concerns on receiving a letter that indicated they would be served with notices to quit. Old Windsor Parish Council immediately submitted a request, and evidence, for the building to be listed to English Heritage. Thankfully this was successful and the threat of a developer acquiring the site was averted. Simultaneously your borough councillors were in discussion with RBWM regarding the situation with the residents and ultimately buying the site The borough were outbid but we were pleased that the new owner honoured the existing tenants' contracts.

Heathrow operations were hit badly by the Covid pandemic and this affected the livelihoods of residents. It will take some time to see a return to previous flight numbers. We will continue to monitor noise levels through various organisations.

Borough Finances

In 2019 we informed residents that a lack of financial prudence had resulted in unsustainable budget setting in 2018/19 and put huge strain on council officers to maintain services, across the board, while having to off-set a £10.6 million deficit in the 2019/20 services budget.

To balance the accounts we have seen a number of cuts or increase in fees

- downgrading the residents parking discount scheme
- charging for parking permits
- cancellation of capital projects
- reducing the council tax subsidy for low earners
- cuts to funding for Early Years/Youth Services
- Increase in parking charges
- cuts to Library opening hours
- removal of grants to community groups.
- Reduction in Community Wardens from a promised 25 to 6



The basics of this budget is that there is no option but to **raise council tax by the maximum allowed, this year and for the next 4 years.** Despite these increases it is still necessary to find another 13 million savings by February 2026.

This year's budget was set in place by decisions made up to 5 years ago. Outsourcing..... pushing for cheaper and cheaper contracts without assessing the impact on the quality of service. The loss of knowledge and control through redundancies. Spending on projects (and running up the councils debt) without having guaranteed income that could be realised.

Our debt is estimated to reach over £230m this financial year and our borrowing cost will grow to £8.6m annually.

Being Independent we have been challenging the decisions made by the ruling Conservative administration but were ignored.

The stranglehold that the administration continues to place on the Overview & Scrutiny process, despite two consecutive Peer Group reviews calling for change, restricts the only mechanism that enables true challenge to take place.

Now the Conservative administration need to take responsibility for the situation they have created and not just make excuses.
